Study tours in culture

About House of Europe

House of Europe is a new EU-funded programme fostering professional and creative exchange between Ukrainians and their colleagues in EU countries. The programme focuses on different professional fields: culture and creative industries, education, health, social entrepreneurship, media, and youth.

This encompasses 20+ separate programme lines enabling to go for conferences, professional events, internships, and networking in the EU, or to enroll in study tours, residencies, trainings, and other forms of support. House of Europe funds cultural coproductions and cooperations between Ukrainian and EU organisations, along with the development of cultural infrastructure and artistic concepts for youth in Ukraine. Finally, the programme offers various youth camps and an intra-Ukrainian university exchange.

About study tours

A study tour is a group trip for professionals that includes workshops, lectures, seminars, discussions with experts from EU countries, networking, and visiting relevant professional events.

The aim of a study tour is to give professionals the opportunity to experience first-hand EU approaches and methodologies, to internationalise their networks, and to initiate cooperation with their colleagues in the EU.

Each study tour will take place in one of EU country¹ * in one or more cities. Study tour programmes are developed by the House of Europe team and implemented with partners from the EU and Ukraine.

Each group will consist of (up to) seven participants, professionals in the field of culture and creative industries. Moreover, an accompanying person and a translator will be part of each group.

Each study tour has a different focus and thus targets different groups of people. For professionals in culture and creative industries House of Europe plans to offer study tours in fields such as:

- Theatre
- Music
- Literature Design
- Fashion
- Cinema
- Museums
- Contemporary dance
- Art market
- Cultural heritage
- Archives
- Restoration and conservation

Who can apply?

You must be a resident of Ukraine and must be at least 18 years of age.

You must be a professional working in the sectors of culture and creative industries. This includes, but is not limited to the following:

- Managers, curators, cultural operators, experts/researchers, and cultural entrepreneurs in the fields of music, literature, theatre, dance, cinema, design, fashion, museum, art market, cultural heritage, archives, restoration and conservation
- Artists (music, literature, performative arts, graphic/fine arts, sculpture, media/concept art)
- Employees of local government culture departments

You can apply only individually; group applications cannot be considered.

Good to know

- You can apply only for one study tour within one call.

- If unsuccessful, you can apply again in the next call – provided that the topic and professional field will be relevant for your experience.
- You can participate only once in House of Europe study tours.
- However, you may still be eligible to apply for other House of Europe opportunities.

When can I participate in study tours?

Study tours will be held twice a year – in spring and autumn. Depending on your profession and focus, you can choose between six study tour offers per year.

The study tours for the 2019 open calls will take place between 15 February and 15 April 2020.

Depending on the programme, the duration of the study tour will vary from 7 to 14 days.

What do I need to apply?

- You must have a biometric passport
 - or ability to acquire a biometric passport in time before start of the tour
 - and/or ability to receive a visa to an EU member state (it is your responsibility to obtain all necessary visas and travel documents).
- You must be admissible to EU.

What expenses are covered?

Participation in study tours is completely free of charge. The programme undertakes to cover:

- Travel expenses
- Accommodation
- Meals (breakfasts and dinners)
- Participation in the activities and events specified in the programme of a study tour, including accession or registration fees, tickets, etc.
- Translation for study tour group

What expenses are not covered?

- Health Insurance
- Participants' personal expenses

How do I apply for study tours?

To apply for a study tour, please submit your application along with the necessary supporting documents on the House of Europe online platform: houseofeurope.grantplatform.com.

You need to submit your application (button 'Submit entry') by 14 November 2019, 15.00 Kyiv time.

How do I fill out the online application?

- You have to register on the online platform to be able to fill in the electronic application
- You need your email to register on the online platform
- We will use this email to communicate with you, so we ask you to register on the online platform with an email that you check regularly.

- We encourage you to use the Europass format to structure your CV. It is a clear and informative standard and will help you to present your information as clearly and completely as possible, and for the experts to evaluate it as objectively as possible:

Recommendation letters

- References from your partners, experts in your field

- An electronic application consists of the following tabs: 'Details', 'Questions', 'Criteria', 'Attachments', 'Declaration'.
- All tabs consist of mandatory and optional fields
- Optional fields are marked 'optional'.
- You cannot move to the next tab and save the application unless mandatory fields have not been filled.
- To submit an application, please press the button 'Submit entry'.
- Once you click 'Submit entry' the application is forwarded for review, and you will not be able to make changes or upload files any more.
- If after clicking 'Submit entry' you do not receive an automatic confirmation, the application has not been submitted. In that case, please check again, and/or get in touch with us via email kateryna.dymova@houseofeurope.org.ua.
- Please submit your application in advance, as there may be additional load on the online-platform shortly before the deadline.

How will my application be evaluated?

Your application will go through two stages of assessment. First, your application will be checked whether it meets technical criteria.

If compliant with technical criteria, your application will be forwarded for a review by independent experts, who will evaluate it based on established and public selection criteria.

If your application is successful, you will be invited to sign an agreement with House of Europe. The grant agreement will stipulate rights and responsibilities of the grant beneficiary and House of Europe, as well as detailed conditions of study tour.
